What is this product?

Type: This product is a sub-fund of Atomo, an open ended investment company with variable capital and an umbrella fund with segregated liability between the sub-funds, established under the laws of Luxembourg and authorised by Commission de Surveillance du Secteur Financier as a UCITS for the purposes of the Luxembourg law of 17 December 2010 relating to undertakings for collective investment, as may be amended from time to time.

Intended Retail Investor: Suitable for investors with a medium to long-term time horizon, typically five years or more.

Term: This Fund has no maturity date.

Objectives:

We aim to achieve returns in excess to that of the bond market over time.

We invest mainly in bonds (loans) issued by companies worldwide that pay higher interest than other bonds. Issuers are rated by specialised consultants on a scale from A (best creditworthiness - high probability to meet interest and capital repayment obligations) to C (worst creditworthiness, vulnerable issuer). We typically invest in issuers that are less vulnerable in the near term although facing long term challenges (BB+ to B- Standard & Poor's rating). We select those on the basis of a thorough analysis of their financial situation and business perspectives. We may invest in all other types of bonds such as those issued by governments or convertible into shares. We may also invest in units of investment funds investing in bonds. This Fund is actively managed meaning that the investment manager has, subject to the stated investment objectives and policy, discretion over its portfolio, with no reference or constraint to any benchmark. In accordance with article 6 of EU regulation 2019/2088, the subfund does not promote environmental or social characteristics nor has as objective sustainable investment, as further disclosed in the Prospectus. This Fund does not either take into account the EU Taxonomy criteria

Risk indicator



The risk indicator assumes you keep the product for 5 years. The actual risk can vary significantly if you cash in at an early stage and you may get back less than your original investment. In addition to the market price risk, please refer to the Fund's Prospectus for further information.

If the Fund currency differs from your investment currency, you will receive payments in a different currency, so the final return you will get depends on the exchange rate between the two currencies. This risk is not considered in the indicator shown above.

We have classified this product as class 3 out of 7, which is a medium-low risk class. This rates the potential losses from future performance at a medium-low level. Poor market conditions could impact your returns.

Performance scenarios

What happens if the Company is unable to pay out?

What are the costs?

Costs over Time

The Reduction in Yield (RIY) shows what impact the total costs you pay will have on the investment return you might get. The total costs take into account one-off, ongoing and incidental costs. The amounts shown here are the cumulative costs of the product itself, for two different holding periods. The figures assume you invest USD 10,000.
